JOINT CHECK PAYMENT AGREEMENT

Buyer has ordered materials from RSI Building Products LLC, RSI Building Products of Alexandria LLC, and RSI Building Products of Hammond LLC ("RSIBP") for use in the project listed above ("the Project"), and has requested that RSIBP sell the materials to Buyer on credit. General Contractor irrevocably agrees to issue joint checks payable to both Buyer and RSIBP, commencing on _____, and for so long as RSIBP makes credit sales to Buyer in connection with the Project.

General Contractor shall deliver each joint check to Buyer. Buyer shall immediately endorse each joint check and forward it to RSIBP. RSIBP shall then apply the proceeds of the joint check in payment of any amount due RSIBP from Buyer. From the proceeds of the General Contractor's check, RSIBP shall issue a check to Buyer in the amount that the joint check exceeds the amount due RSIBP from the Buyer.

If Buyer does not endorse and deliver any joint check to RSIBP within ten days after Buyer receives that joint check from General Contractor, General Contractor shall stop payment on

that joint check. General contractor shall then immediately deliver to RSIBP a new check made payable solely to RSIBP (in the same amount as the joint check previously issued). RSIBP shall then deposit the newly issued check, applying the proceeds of the check against the amount due RSIBP from Buyer on invoice(s) relating to the Project. RSIBP shall issue a check to Buyer in the amount that the newly issued check exceeds the amount due RSIBP from Buyer, if any. Buyer agrees that any check issued by General Contractor directly to RSIBP under the procedure stated in this agreement shall constitute payment to Buyer to the same extent as if Buyer had received, endorsed and forwarded General Contractor's originally issued joint check in accordance with this agreement.

In the event any party to this agreement breaches the agreement, the prevailing party shall be entitled to reasonable attorney's fees and costs for any claim or action made or filed against the breaching party or parties.
